This letter is formal notice to you and your student(s) concerning the seatbelts on our school buses. Chico Unified School District is making every effort to insure the safety of our students. We are in the process of replacing our big buses. The new buses are equipped with seatbelts.

**Vehicle Code Section 27315** states that all passengers are required to wear seatbelts on vehicles equipped with them.

It is your student's responsibility to wear the seatbelts when on the bus. Students not wearing or not properly wearing seatbelts will receive a citation. Students who continue not wearing their seatbelt could lose their privilege to ride the school bus.
